Dear Ms. McAvoy:

Have you read the emails in that box of documents? I may have purchased the most interesting "book" I've ever read. Expensive, but very interesting and educational... and depressing. There are military spawned acronyms that would be appropriate for labeling the handling of County communications.

We've finished putting the document copies in chronological order and have scanned them to searchable PDF files. However, before we "stitch" the files for uploading, we would like to fill some serious gaps, if necessary. Do you have an extra stack of copies left over in your office that didn't make it back into the box? I ask because there were no docs for January through May of 2012 and no docs for August through December of 2015. I think it's odd that those 10 months produced no records relating to digital fire service communications or "fire west".

As you probably realize, you owe me a refund. There were **117 totally blank pages** and **349 pages that are not related to the requests** (e.g., 190+ pages of the State's contract with Motorola, 200+ pages relating only to police radios).

We can deal with all that in court along with some FOIA compliance issues, but I would like to have the documents from the 10 months for which we received nothing unless you can certify that during those 10 months there were no records generated relating to my FOIA request topics.

If you haven't just mislaid them and don't have them immediately available, please let me know so I can transmit what we have already scanned.

Thanks for your cooperation and please thank Mr. Jerman for accomplishing what I'm sure was a very boring task.

BTW, were you at anytime in your life (or another life) a professional card dealer? The documents were very well "shuffled".
